

**ENFORCEMENT OF PRIVATE MEDICAL INSTITUTIONS
(REGISTRATION) ACT 21 OF 2006**

Notice is hereby given by Gazette notification No. 1489/ 18 of 22nd March 2007 issued by Hon. Nimal Siripala De Silva, Minister of Healthcare & Nutrition that it is mandatory to Register all Private Medical Institutions with the, **Private Health Services Regulatory Council and pay the appropriate fee.** Failure on the part of an individual or a practice to comply will carry a penalty. A fine and an imprisonment and also an order for closure.

Categories of Private Medical Institutions & Registration Fees.

7. **Part time Medical Specialist Practices (Employed by Government or other registered medical institution)** - SLR 10,000/-

8. Private Ambulance Services	- SLR 10,000/-
9. Other Private Medical Institutions	
a) Blood Banks	- SLR 25,000/-
b) Stem Cell Banks	- SLR 50,000/-
c) Dental Laboratories	- SLR 5,000/-
d) Home Care Nursing Services	- SLR 5,000/-
e) Medical Man Power Training Institutions	- SLR 20,000/-

Completed Application forms should be forwarded to the Secretary – Private Health Services Regulatory Council, Ministry of Healthcare & Nutrition, “Suwasiripaya” with the recommendation of the relevant Provincial Director of Health Services either with a Bank draft or a Bank remittance slip as the relevant registration fee. A certified copy of the Sri Lanka Medical Council registration certificate of the medical person in charge should be submitted with the application form.
